



Here are five reasons why members of a Chapter do not contribute to a Chapter Newsletter.

# Minutes of September Meeting By Stan Solecki for Charlie Maxted

The September meeting of EAA Chapter 27 was called to order at 10:05 a.m.

Jeff Davenport reported on the RV seminar at Fulton, NY. He also noted that their chapter has a great hangar and a clubhouse on the field.

A photo of the Meriden Airport was published in a recent edition of the Meriden Record-Journal. Some changes have occurred as the hangar shown was blown away during the hurricane of 1938. The CAP headquarters has since been torn down.

A survey was recently taken comparing the number of accidents between homebuilt and factory built aircraft. It was found that homebuilts proved to have the higher rate of accidents (17 out of 1,000 compared to 6 per 1,000 for the spam cans).

Young Eagles Day is scheduled for October 21 at MMK and pilots, aircraft and volunteers are needed to make this day a success

Up to date 150,000 Young Eagles have been flown. Chapters are asked to fly at least one Young Eagle per member. This will double the figure.
