
A LETTER FROM PAUL

Paul Poberezny recently sent a letter to Chapter Presidents and newsletter editors. Most of it was newsletter ideas, such as making sure the Chapter contact information is included. But the final paragraphs have relevance to us all:

March 7, 2007

Having played a significant role in the amateur-built aircraft program for over half a century since its beginning working with the then CAA and now FAA, I have seen the true amateur builders add significantly to the development of the homebuilt movement and an earned safety record. That our government gave its citizens or a group of individuals the privilege to design and build an airplane for educational as well as recreational purposes is a great gift-many meetings and discussions were made on the merits of such a program. Safety issue examined the destructive powers that the weight of the light aircraft might have in the event of damage to the public in an accident where they were to be flown in the initial test areas and thereafter, as well as the carrying of passengers. A reasonable safety record for the movement in those early days was earned - even other countries sought our input and allowed their citizens the same privileges.

The 51% rule: With hand and mind you could create your own aircraft. The 1%



over the 50% gave us a very slight margin over the builders having to build one half of the airplane. It also allowed for items that could be used in the construction, such as engines, wheels, brakes, propellers, instruments and other such off the shelf hardware. Through the freedom the movement has earned great educational opportunities and an education has been gained.

From time to time I have been asked could this wonderful privilege be lost? I guess I would have to say "yes."

MEETING MINUTES

February 18, 2007

Call to order: The meeting was called to order by President Jim Simmons at 10:00 a.m. with all officers and 35 members present. There were no visitors today.

Treasurer's Report—Bill Jagoda: Bill reported a balance of \$557.29.

Technical Counselor Report—Dave Pepe: Dave reported that he did not receive any calls to look at projects. Dave briefly explained the process for inspecting a homebuilt aircraft and mentioned the "Homebuilder's Kit" which can be purchased from EAA. Dave said that his nephew, Jim, is expecting the fuselage kit for his RV-9A next month. Also, Mike Zemsta has mounted his IO-540 to his RV-10.

Young Eagles-Fran Uliano: Fran explained that he has met with a Boy Scout group and they are looking forward to flying in June. Fran and Dave Pepe are also working on getting a price for Young Eagles t-shirts to determine if we should offer them for sale at our Young Eagles events. The FAA may impose a new ruling which affects charitable flights and which may also affect the Young Eagles program. However, Tom Poberezny will be meeting with FAA administrator, Marion Blakey, to avoid any harm to the Young Eagles program. Many believe that this new ruling was not originally intended to hurt the Young Eagles program and that adjustments will be made.

Bulletin Board—Chris Kohler: Chris explained that there are no pictures on the bulletin board because no one has submitted any pictures and urged everyone to submit some pictures so he can post them.

Membership — Mike Okrent: Mike stated that we have 59 paid members for 2007. Jim urged everyone to please pay their dues. Again, the friendly reminder to pay your dues is the lack of a membership badge

with your name on it.

Website and Newsletter—Rick Beebe: Rick explained that our Tool List is up on the web site, in the member's section and to access the member's section of our web site you must enter your EAA number as the username and your last name, in lower case letters, as your password. Old Business: Heather Woiciehowski and Jim are working on setting a date for us to tour the New York TRACON, possibly in May. Heather also mentioned that her husband, Leon, is now working at the New Haven Tower.

Rick Bernardi, who is on the hangar committee, will address some missing contact information. The new hangar estimated cost is now \$45K.

New Business: Jim has spoken to new FAASTeam (FAA Safety Team) Program Manager, Jim Adams, at the Windsor Locks FSDO. Jim Adams is interested in speaking to our Chapter in the near future. Jim also said that there will be no Safety Fest this year mainly due to dwindling participation over the past few years.

There was some brief discussion about the FAA's proposed user fees they are working towards implementing. Bob Spaulding suggested to the membership that writing letters and/or emailing our political representatives, opposing user fees, would be helpful.

Possible new seminar topics included presenting various aircraft maintenance tools and their applications and the responsibilities of a technical counselor.

50/50 Raffle Winner: Kare Wakelee won the raffle today! Congratulations, Kare!

Seminar Presentation: Bob Spaulding presented an important and technical presentation on a very critical subject: weight and balance. Bob broke his seminar into three categories: Center of Gravity, Grease, and Gravity. Bob covered the aerodynamics of a wing and where the center of lift occurs and how it varies. He also mentioned the NACA reports which are airfoil data collected from World War I to the present and which are key to understanding CG. He used his Hatz biplane as an example and showed some fantastic, tail-standing video of an S-92 Sikorsky helicopter performing an autorotation at maximum gross weight and a CG at the limit. Very interesting!

Meeting adjourned approximately 12:10 p.m.
