The are pleased to report that as a result of a scholarship from EAA headquarters and EAA Chapter 27 earned credits for 2008 Young Eagles flights we will be able to cover 100% of the cost for Isaiah Tiezzi to attend the EAA Air Academy in Oshkosh this June.

#### LETTER FROM THE PRESIDENT

As you all know I generally try to keep my monthly letter upbeat and supportive of our activities and our membership. However this month I feel compelled to write to remind our members of the need for vigilance against the assaults on general aviation. More than ever, the privileges we have enjoyed for many years are consistently being attacked by bureaucrats and our politicians. While they personally enjoy the flexibility that general aviation provides every one of them, they seek to take actions to restrict us in every way.

We've seen repetitive efforts at implementing user fees. The most recent news is that they will not be imposed in 2010, but they are certainly on the table. In an FAA budget brief released by the Department of Transportation May 7, the Obama Administration calls for the air traffic control system to be paid for by user fees: "Starting in 2011, the budget assumes that the air traffic control system will be funded with direct charges levied on users of the system." The obvious effort is to wear down the opposition and implement fees sooner or later.

Under the guise of improved airport security (which I personally find redundant and ridiculous) the TSA has been doing their part to restrict the liberties of general aviation as well. The latest TSA security directive (1542-08F) is featured elsewhere in this newsletter. It most certainly is onerous upon airport management and seeks to further restrict the activities we all enjoy.

I urge every one of you to stay vigilant. Read the newspapers, read the aviation magazines, read aviation related internet updates on these issues. Join the efforts of the EAA and the AOPA when called upon. Write your senators and congressman and become an advocate for general aviation.

It's not too late. I strongly believe that if we don't attempt to fight this now, future generations of Americans will no longer have the ability to enjoy the wonders of general aviation. If not for yourself, think of it as you're doing this for the over 1.4 million "Young Eagles" we've all been working so hard to cultivate. I urge you please, let's not be the end of an era; let's be the protectors of the future.
